
#### LETTER FROM GOVERNOR

#### LETTER FROM EXECUTIVE DIRECTOR

I would like to thank the Governor and the Alabama Legislature for their continuing support of GOOD. FY 2008 and FY 2009 have been two years of positive growth and change for the office. Governor Riley signed Executive Order 43 which more clearly sets out the duties of the office. Nine local advisory committees have been created around the state to solicit grassroots input about unmet needs of people with disabilities and to increase the visibility of the office. Likewise, a State Advisory Committee was formed to provide overall input to GOOD from different persons with disabilities and disability organizations. GOOD in partnership with its advisory groups developed a new mission statement and strategic plan. The GOOD website has been updated to increase its usefulness for Alabama's citizens. Meetings have been held with other state agencies to foster collaboration and maximizing of state resources for persons with disabilities. A special thanks is given to the Alabama Department of Rehabilitation Services for its close partnership with GOOD.

Information about disability issues and training has been delivered throughout the state. Awareness is a powerful tool which leads to greater access for individuals with disabilities. GOOD continues its role of dispensing accurate information. In 2009, GOOD held its Inaugural Disability Summit. Its purpose was to convene major state agencies and non-profit organizations serving people with disabilities to identify resources and top issues. ### **GOOD** Overview

The Governor's Office on Disability was created by Executive Order in 1999. It was formed to serve as a statewide clearinghouse for information on disability in Alabama. Its other major function is to act as a liaison to the Governor's Office on disability issues.

The Governor's Office on Disability's mission statement was revised in 2008 as follows:

Facilitate the inclusion of Alabamians with disabilities in education, employment, housing, transportation, health care, and leisure.

Governor Riley's Executive Order 43 in 2008 significantly clarified and refined the duties of Governor's Office on Disability. Resources are scarce in Alabama. The Governor's Office on Disability seeks to maximize disability resources by identifying existing ones and fostering collaboration among public and private entities that serve people with disabilities.

The Governor's Office on Disability actively seeks to engage communication between individuals with disabilities and their families and entities that provide services to them. GOOD's web site, <a href="https://www.good.alabama.gov">www.good.alabama.gov</a>, is one tool that is being expanded to facilitate open dialogue and access on disability resources and issues. Additionally, GOOD held its first Disability Summit to bring together leaders of public agencies and non-profit organizations that serve individuals with disabilities. Common issues and resources were identified.

To foster communication even more, GOOD developed a listserve. Anyone interested in issues affecting people with disabilities can join the GOOD list by accessing the website at <a href="www.good.alabama.gov">www.good.alabama.gov</a>, clicking the "Join the GOOD List" icon and entering in personal contact and e-mail information. Periodically, cutting edge information on disability will be shared with list members.

Act as an expert resource regarding the implementation of the Americans with Disabilities Act and related laws.

#### (4)Dissemination Initiative

Promote public awareness of actions and activities in fulfilling GOOD Mission.

Increase effective utilization of available resources for Alabamians with disabilities.

#### Objective 2:

Establish a website as the primary dissemination method of GOOD actions, activities and publications.

#### **EXECUTIVE ORDER NUMBER 43**

- WHEREAS, on March 2, 1993, Executive Order No. 52 was signed, which created a division under the Alabama Development Office known as the Americans With Disabilities Act (ADA) Development and Compliance Section, and on April 28, 1999, Executive Order No. 7 was signed, which created the Governor's Office on Disability; and
- WHEREAS, passage of the ADA by the United States Congress imposed a requirement that employers not discriminate against people with disabilities in regard to any employment practices or terms, conditions, and privileges of employment; and
- WHEREAS, Congress specifically mandated that state government agencies be subject to the provisions of the ADA; and
- WHEREAS, the Governor is vested with the responsibility of making executive decisions which affect children and adults with disabilities and their families, and he is keenly aware of the economic impact of disability on these individuals; and
- WHEREAS, the Governor also clearly recognizes that persons with disabilities have a tremendous positive impact on the State of Alabama, its economy, and society in general, but that they may have special needs and requirements to facilitate their efforts, work and interactions; and
- WHEREAS, the Governor recognizes that people with disabilities have unmet needs in many areas, including, but not limited to, transportation, education, employment, housing, recreation, insurance, personal assistance; and
- WHEREAS, the Governor is committed to fostering collaboration among public and private organizations serving individuals with disabilities in order to efficiently use available scarce resources; and
- WHEREAS, the Alabama Department of Rehabilitation Services (ADRS) is the one state agency providing a continuum of services from birth to old age for Alabamians with disabilities; and
- WHEREAS, the Governor is committed to appointing effective, knowledgeable persons to those positions impacting people with disabilities, and to seeking increased inclusion and participation of people with disabilities in state programs and services; and
- WHEREAS, the Governor has further need of executive coordination of input from and output to consumers and consumer-driven organizations regarding state disability policies and services and a clearinghouse for disability-related information at one location;
- **NOW THEREFORE**, I, Bob Riley, Governor of the State of Alabama, by virtue of the authority vested in me by the Constitution and laws of Alabama, and for other good and valid reasons, which relate thereto, do hereby establish the Governor's Office on Disability, hereinafter referred to as "GOOD."

The purpose and duties of GOOD include:

- (1) In conjunction with ADRS, serve as point of contact in the Governor's Office for issues related to people with disabilities.
- (2) Collect and compile information on Alabama resources for individuals with disabilities and their families.
- (3) Serve as liaison to the Governor on disability issues.
- (4) Monitor Alabama legislation and policies that affect people with disabilities and provide information to the Governor.
- (5) Collaborate, where possible, with other Alabama public and private disability organizations and resources to increase efficiency in the use of available resources for Alabamians with disabilities.
- (6) Accept and handle referrals, regarding disability issues, from the Governor's Constituent Affairs Office.
- (7) Enter into inter-agency agreements with any State agency or organization(s) to further the purposes of GOOD.
- (8) Monitor disability constituent issues to the extent of developing, assisting in the development of, or recommending policies and/or legislation to address such issues in coordination with the Governor's Policy and Legislative Affairs Offices.
- (9) Maintain local advisory committees around the state for the purpose of determining the unmet needs of persons with disabilities and otherwise soliciting their input and reporting this information to the Governor.
- (10) Provide informal legal opinions on disability issues to the Governor's Legal Office and otherwise assist such office on legal matters related to individuals with disabilities.
- (11) Serve as a statewide clearinghouse for information on disability issues.
- (12) Prepare an Annual Report of GOOD's activities and send a copy of said report to the Governor, the Alabama Legislature, and the Commissioner of ADRS, and provide quarterly reports on GOOD activities to the Governor.

Executive No. 43 Page three

BE IT FURTHER ORDERED, that GOOD shall be managed by an Executive Director, who shall be appointed by, and serve at the pleasure of, the Governor.

BE IT FURTHER ORDERED, that the Executive Director shall be assisted by a Deputy Director, who shall be appointed by, and serve at the pleasure of, the Governor.

BE IT FURTHER ORDERED, that all employees of GOOD, present or future, be supervised, managed and answerable to the GOOD Executive Director and that GOOD shall be housed and located within ADRS and subject to its personnel policies, rules, and regulations, to the extent available, yet will remain a separate agency.

BE IT FURTHER ORDERED, that if a conflict arises with regard to any previous or existing Executive Order, the provisions of this Executive Order shall prevail.

BE IT FURTHER ORDERED that this Executive Order shall become effective immediately upon the Governor's signature and shall remain in effect until amended or modified by the Governor.




